- Fornoff moved to approve Rule 13-4-2 to change inspections from 4 years to 5 years. Seconded by McConville.

Nelsen moved to delete Rule 9-1.14, Appendix 1.1.7 and 1.9.2 as presented at the hearing. Seconded by Loomis.

Discussion was held on both sides with Anderjaska and Schilling stating their reasons for voting against is the desire to wait for AEM to present their model to us for more informative use before making changes to the rules.

8. MANAGER'S REPORT

- A. Nitrogen Reduction Incentive Act. Russell went over the legislation that has been passed. DNR will be allocating funds to each district which they are only based on acres at this point.
 - B. Stay on Variances.
 - Anderjaska moved to put a stay on transfers of wells and certified acres until November 2025. Seconded by Schilling.

9. GW COMMITTEE – VARIANCE REQUEST

Russell went over the variance request submission which was denied and pushed to the GW committee and now to the Board. Discussion held.

- Nelsen moved to approve variance and waive the 2 criteria on depletions and development but not the criteria on well spacing and adhere to drilling in the ¼ that was presented on the map. Seconded by Fornoff.

11. NARD - ANDERJASKA

Updated the board on their recent meeting and the Governor's thoughts on taking water quality out of DEE and assigning it to DNR and requiring state-wide metering.

12. NRC - FORNOFF

December 11th will be the next meeting. Reminder, he will not be running for the position again and encourage someone from the board or in the district to pursue some interest in running. Elections will be held in January.

13. NSIA – SCHILLING

They have a joint conference coming up November 24-26 and anticipate a meeting will be called prior to that but have not received notice yet.
